The bids will be opened in the presence of Bidders' representatives who choose to attend at *14:00* on 31st january 2020 at the Dashrathchand Municipality, Office of Municipal Executive, Baitadi. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of **NRs. 50,000.00** which shall be valid for 30 days beyond the validity period of the bid.
