The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 16th October, 2020. at the Dasharathchand Municipality, Office of Municipal Executive *Baitadi*. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of NRs. 288,000.00 which shall be valid for 30 days beyond the validity period of the bid.
